A deposit of 50% must accompany all NEW or FIRST TIME applications. If awarded a well assignment, the balance will be paid in accordance with the dock rules.

1. If you had a well in 2009 and wish to retain that well, DO NOT submit an application. You will be billed in two installments – the first on your January 31 statement and the second on your March 31 statement.
2. Assignments / reassignments must be submitted in writing and will not be accepted until January 1, 2010. **VERBAL REQUESTS WILL NOT BE ACCEPTED. NO EXCEPTIONS!**
3. Incomplete applications will be voided and returned.
4. If you wish to relinquish your dock, please notify the Fleet Captain in writing prior to January 15, 2010 to avoid billing and possible loss of deposit.
